## Release of Liability and Indemnity Agreement The Orange County Burrito Project

I, \_\_\_\_\_, understand and acknowledge that my participation as a volunteer for The Orange County Burrito Project (“OCBP”) exposes me to risk of personal injury, including the possibility of serious personal injury and loss or damage to personal property. I accept all the risks of participating in or observing such activities. The “Risks” to which I may be exposed include, but are *not* limited to accidental injury from serving hot food, accidental injury from motorized vehicles, altercations with or assault by intoxicated and/or mentally ill individuals, exposure to harsh weather conditions, injury sustained from walking in dark and remote areas, transmittal of viruses, bacteria or pests (lice, bed bugs, etc.), and emotional distress from seeing clients in poor conditions. I EXPRESSLY AND VOLUNTARILY ASSUME ALL RISK OF PERSONAL INJURY OR PROPERTY DAMAGE THAT MAY RESULT FROM MY PARTICIPATION AS AN OCBP VOLUNTEER.

If I am driving a vehicle to or from or during any activity as a volunteer of OCBP I represent that I have a valid driver's license as well as motor vehicle insurance in compliance with California Law. I understand I am not covered under any insurance other than my own. I UNDERSTAND THAT I AM SOLELY RESPONSIBLE FOR ANY TRAFFIC OR PARKING TICKETS OR DAMAGE TO MY MOTOR VEHICLE AND INDEMNIFY OCBP FROM ANY CLAIM ARISING OUT OF SUCH ACTIONS.

I agree to refrain from taking pictures of any contact without consent and that no photograph will capture the faces of clients without the client's express consent. I UNDERSTAND AND AGREE THAT OCBP, AT ITS SOLE DISCRETION, MAY TERMINATE MY PARTICIPATION AS A VOLUNTEER AT ANY TIME AND FOR ANY REASON.

I hereby consent that my work as a volunteer, in which I may be featured in whole or in part, whether separate from or in conjunction with, illustrative or written story or news item, motion pictures, television or radio spots, or for publicity, advertising, social media or any other lawful purpose whatsoever, in conjunction with my name or in anonymity, be photographed or otherwise documented by OCBP. I hereby waive any right I may have to inspect and/or approve the finished product or the advertising copy that may be used in connection therewith or the use to which it may be applied. I hereby waive all claims for compensation of such use or for damages. I UNDERSTAND THAT OCBP MAY USE PHOTOGRAPHS OF MY WORK AS A VOLUNTEER ON THEIR PROMOTIONAL MATERIALS.

In executing this agreement, I DECLARE UNDER PENALTY OF PERJURY under the laws of the State of California that I am doing so only for myself and/or on behalf of persons for whom I am the parent or legal guardian.

I understand and agree that this agreement is severable and that if any clause is found to be invalid, the balance of the contract will remain in effect and will be valid and enforceable.

I agree that any action against OCBP will be brought in the County of Orange in the State of California with any disputes subject to and determined under the laws of the State of California with each party bearing their own attorneys fees and costs.
